I authorize the use of this signature on all my insurance and/or employee health benefits claim submissions.

MEDICARE

I certify that information given by me in applying for payment under Title XVIII of the Social Security Act is correct. I request that payment of authorized Medicare/Other Insurance company benefits be made to me or on my behalf to ROA for any services furnished to me by that party who accepts assignment/physician. Regulations pertaining to Medicare assignment of benefits apply. I authorize any holder of medical or other information about me to release to the Social Security Administration and Health Care Financing Administrations or its intermediaries or carriers any information needed for this or related Medicare Claim/other Insurance Company Claim. I permit a copy of this authorization to be used in place of the original, and request payment of medical insurance benefits either to myself or to the party who accepts assignment.

PATIENT PRE-CERTIFICATION RESPONSIBILITY
